# Minister's Message from Rev. Jane Capstick

Our pandemic years are a bit like being in the ark with Noah, his family and the animals. We were indoors, with our families or pets or alone waiting for the storm to pass. After 40 days of rain Noah parked the Ark while the animals peaked outside and considered how the landscape had changed. A bird was sent to investigate and returned with an olive branch. Not unlike our own first steps into groups, gatherings and church when we peeked out the window wondering if it was safe. At the start of 2022 a new variant made it clear that it was not yet time to disembark. Yet, by the end of 2022 many of us had walked down the ramp, removed our masks, and rejoined a slightly different world.

Throughout the flood Silver Spire kept doing ministry. We continued to offer food, shelter and showers to those left out in the rain. We connected in person and over Zoom to nurture our spiritual lives. It has been a year of slowing walking down the ramp to find our way back to our church and life. It has been wonderful to see people returning to the pews, ministries and programs of the church.

One great joy that returned in 2022 was coffee hour. It is such a delight to gather in person with a cup of coffee after church. It is a time when we build connections, offer pastoral care, hear church news and simply be together. After such a long time of isolation just sharing a cup of coffee feels like such a gift.

I was grateful to take a sabbatical during 2022 which was both renewing and restorative. The beginning of my sabbatical was a two-week online course, Interim Minister Training. This course provides training for ministers leading in the midst of conflict or transition. As we live through this pandemic every church is experiencing change and transition. It was an engaging course with participants from across denominations and North America. The remainder of my sabbatical was to truly engage in Sabbath time. I learned the importance of deep rest which can be transformative and healing. When I returned from my sabbatical time, I felt energized and excited for the ministry of Silver Spire.

I am astounded by Silver Spire's vision and willingness to be present for each other and our community. As you read through this annual report you will hear about the many ministries which are supported by the congregation and community. Once again, we are looking at our strategic plan and listening for God's call to Silver Spire. I wonder if Noah's family created a plan for the future after all the rain? Let us look for the signs, the rainbows, the hope that is God's call for our church.

There will be challenges and blessings as we move onto dry land. Yet, on this land we can build, evolve and look to the future. We sow seeds and wait for God to reveal the blessings which will grow.

# Minister's Message from Rev. Karen Orlandi

I enjoy reflecting on the year that passed in the church; it's both exciting and nostalgic. And to take a moment to look ahead to a new year, with hope and enthusiasm. In 2022, I moved my calendar from being paper-based to electronic which was a great, but challenging move, so now I am swiping through the pages to see what happened in those olden days of 2022...

I see weddings, funerals and baptism, of folks who come regularly to Silver Spire and those who know us from the edges. I see General Council 44 where we elected a leader of the United Church of Canada, the Reverend Dr. Carmen Lansdown, Moderator, who is a member of the Heiltsuk First Nation from First United on the Downtown Eastside of Vancouver. She has a vision for our entire church, which she will lead us through for the next several years.

Under the capable direction of Ally Phillips, Queer Kid Bible Camp was launched to great response. They, along with other youth from our church, filled our float, as Silver Spire, in partnership with Carousel Players and Willow Arts Community, floated down the streets of St. Catharines bringing a message, that, "You're never too old to play!" to everyone at the Grape and Wine Parade.

Our Community Forum on Harm Reduction, brought an important issue to the forefront for the over hundred people who attended, and cemented our role in this community as a place where Arts, Spirituality and Social Justice meet. I couldn't have been prouder than when I read in centre stage, a magazine put out by the Performing Arts Centre that described us as "A progressive church located in Downtown St. Catharines that presents a variety of arts, culture and social justice programs."

We are a church, filled with the Holy Spirit that moves us to be integrated with our community, that challenges us to be more and to do more. We are the church that began the campaign for 24-hour accessible public washrooms, that are days away from being unveiled. We are the embodiment of God in the world. On Sunday mornings, we are here to charge our batteries, fill us up with the words and inspiration of Jesus, who told us to love the Lord our God with all our hearts, but then go out into our communities, and love our neighbour as ourselves.

It is the love of God that we share, that fans the fires of justice, here in our community. The love that we receive from God is not to be hoarded, kept to ourselves like a secret but rather, it is to be shared extravagantly, because we come from a place of abundance. The world around us is in need, desperate need, of what we have to give.

We are at a point in our history where other church buildings are emptying and difficult decisions are being made about the future of Christianity in our midst. It is changing. It is ever-changing, but the love of God, and what God calls us to do, does not change. The new year is an exciting one, and there is much love to be shared.

## **Highlights from 2022**

- Our Arts Education Centre on the top floor (a.k.a. the gym) was busy every month of the year with Theatre School programs, community events, and performances.
- We held our 50<sup>th</sup> Anniversary Festival in April with activities in and around the church, including a makers' market in the parking lot. It was a wonderful celebration that brought hundreds of people to Silver Spire.
- Our big red truck pulled the Silver Spire float in the Grape & Wine parade in September.
- Our first school tour since 2019, *What's So Funny?* had three family performances at Silver Spire in November and December of 2022.

# **Willow Arts Community**

#### Founder, Executive Director: Shauna MacLeod

Willow Arts is comprised of one full-time staff (Shauna MacLeod), a 5-member board of directors, hired local artists and consultants, 25 volunteers, 129 current members and partners in the arts, mental health, and activism sectors.

#### Mandate

Willow Arts Community is an arts and peer support organization dedicated to reducing barriers and providing opportunities for adult artists and creatives with lived and living experience of mental illness/substance use disorder in Niagara. We use the arts as an agent of social change by connecting and engaging with the public through exhibitions, publications, and performances to lessen the effects of stigma and social isolation.

- Welcome In Community Mural!
- Growing our relationship with OUTniagara and Queer Kid Bible Camp.
- Provided over 750 hours of free arts education, hands on art making, and social opportunities for over 2000 individuals.
- Published a zine.
- Was on the planning committee for International Overdose Awareness Day, Harm Reduction Forum, and serves on the Equity, Diversity and Inclusion Committee at the FirstOntario Performing Arts Centre.
- Nominated for two City of St. Catharines Arts Awards and performed at the live event.

To help the congregation engage with matters of social justice through study and action on local, provincial, national, and global levels, and to liaise with other church groups, community groups and agencies in doing so, toward the fulfilment of the gospel command "Feed my sheep."

# **Highlights from 2022**

- Ken Wickens and Cheryl Deslaurier were hired as shower attendants after Rob Case resigned.
- The church provided a warming/drop-in center for those experiencing homelessness from January 24<sup>th</sup> to April 18<sup>th</sup>.
- A donation of over \$700 was sent to Campden Grain Growing Project. They grow grain for the Canadian Foodgrains Bank.
- Groups of volunteers, under the expert guidance of (chefs) Rev. Karen and Ken Wickens, provided 100 to 125 meals each Friday and Saturday evening throughout the summer to those experiencing homelessness. Thank you to each and every person who volunteered in any way.
- We continue to provide between 150 and 200 meals every Monday evening in the winter with the Out of the Cold program. Once again, it is under the guidance of Rev. Karen who has been able to source out donations from many places.
- Jim Agnew resigned from the team. We wish to thank him for his many years of dedicated service.
- A very successful Harm Reduction conference was held November 5<sup>th</sup> with approximately 100 people attending.
- Morning Prayer has been on hold during this year.
- Shower and laundry program is very busy with between 8 and 15 people using it on the 3 mornings per week it is open.

- Morning Prayer will begin again in February. It will include snacks and beverages rather than a full breakfast.
- 100 Mile Potluck dinner which will be part of an educational component on ecological and environmental justice
- One full-day and one half-day community forums the theme to be determined
- Explore the possibility of partnering with other fundraising groups to build a school in the Democratic Republic of the Congo.
- Continue to monitor and supervise the shower and laundry program.
- We provided showers for those experiencing homelessness Monday, Wednesday and Friday mornings. We wish to thank Rob Case for the many years he has co-ordinated this project.

## **Highlights from 2022**

- After the completing the Shower/Laundry project in 2021 we hoped to have a respite from such busyness, but this was not to be. Every act has consequences, mostly unanticipated. An obvious one was the blocking of the sewer line between the church and the street. That the problem was 14 feet below ground did not make repair quick or easy. Thanks to quick action by Jim and Rev. Karen and speedy co-operation from the city, the issue was resolved as quickly as possible and the cause rectified.
- We dealt with a storm window detaching in a windstorm, an issue where preventing a repeat was a priority.
- We faced 3 instances of brief failures of our heating system and have determined that the heating and ventilation systems in our building are complex and aging. In 2022, we began a professional assessment of the entire system with a focus on the immediate need to replace our 60-year-old furnace boiler in 2023.
- We completed an update of our Fire Safety Plan.
- We replaced the carpeting in the Auditorium.
- We added a new door opening system to better accommodate Carousel Players and Willow Arts.

#### Plans and Dreams for 2023 and Beyond

As stated above, it has become necessary to replace our furnace boiler system. This is a major project and expenditure that will take place in May-October 2023. We are continuing to review our other HVAC needs. We know that we will save a substantial amount on heating costs, as the new system will be much more efficient than the existing boiler. We will defer some other upgrades to our building except on an emergency basis.

Verge did a thorough search to get the best rate possible. The premium for 2023 is \$37,288.08. This is a 34% increase from 2022. Due to the pandemic, insurance rates have increased significantly everywhere. There were insurance claims during 2019 and 2020 which still impact our rate.
- We continue the regular review of our investments. We received and reviewed quarterly reviews of our investments from RBC Dominion Securities. Throughout the year, \$200,000 was transferred from the SSUC investments to the general fund as directed by Council. Additionally, a total of \$7,885 was transferred from designated bequests to the UCW, Outreach and Choir.
- This year was a very poor year for the global economy, and this is reflected in the performance of our investments. The Silver Spire Council let us know at the beginning of the year what their projected needs would be and we were able to liquidate some of our holdings to prepare for this. The total value of our investment portfolio at the end of 2022 compared to the end of 2020 was:

• The Columbarium "Care and Maintenance Fund" was updated in accordance with the Bereavement Authority of Ontario regulations. This fund must be held with an independent trustee for the perpetual care of the niches and plaques. There is also a fund to pay for the plaques for any niches purchased prior to April 2018. Our trustee for this fund is the Thorold Community Credit Union.

- to ensure that the investment and insurance needs of SSUC are looked after as responsibly as possible. We are looking forward to our Council planning for the future needs of Silver Spire so that we can monitor the funds accordingly.
- to keep our Vision, Mission and Value statements and the Strategic Plan at the forefront of the work we do.
- to continue the regular review of our investments, insurance, and the Columbarium.

# FINANCIAL STATEMENTS THE BOARD OF TRUSTEES - December 31, 2022

### Notes to the Financial Statements

1. The investments administered by the Board of Trustees include cash and investments from the three predecessor churches which amalgamated on July 1st, 2008 to form Silver Spire United Church. Each of the amalgamating churches had funds which were designated for a specific purpose, or had restrictions on their use. These designations are being maintained, and details of the purpose of the gifts are given below. Also included are the proceeds of the sale of two church properties totaling \$860,120.

A part of the realised change in portfolio value for the year is distributed to the named Endowment funds below. The amount listed as "Total Investment Income" in the Income and Expenses is multiplied by the proportion of the Restricted Funds, divided by the Total Portfolio Value. This amount, net of an inflation increase, is then distributed to the Restricted Funds in proportion to each fund value. This inflation increase is intended to keep the funds at a constant value. The current year's inflation factor for Canada is 6.4%,

The terms of the Endowments require a distribution of income to be made to the UCW from the Falk and Epstein funds, and to Outreach from the Stevens fund. The distribution calculated above is transferred to the UCW and Outreach in the following year. The amounts to be transferred are listed below. These funds, therefore, are increased by the inflation factor only.

Details of the individual endowments and restrictions are as follows:

#### Garner

These funds were given to the choir from the Garner Estate, and are to be used by the choir at their discretion. The choir has used \$1,093.16 of these funds in 2022, which will be transferred to the SSUC General Account in 2023.

#### MacQuillen

These funds were given to be held in trust, and the net income distributed as required for gymnastic equipment.

### Falk and Epstein

These funds were given to be held in trust, and the net income to be paid to the United Church Women on an annual basis for use in the church or the local community. The distribution from 2022 will be \$2,200.

#### Stevens

These funds were given to be held in trust, and the net income to be paid out for the "mission of the church" on an annual basis, and are distributed by the Outreach Committee. The distribution from 2022 will be \$3,500.

### Verge

These funds were given to be held in trust, and are to be used for maintenance of the organ. This endowment was not used in 2022.

### Welland Avenue

These funds were given to be held in trust, and the net income used at the discretion of the Trustees.

### Unallocated

These funds are unrestricted, with no specific allocation.

### 2. Columbarium

Silver Spire is the operator of a Columbarium - a place for respectful storage of cremated remains. The Columbarium niches are located in the basement, between the auditorium and the bowling room. The Columbarium is legally a cemetery, regulated by the Bereavement Authority of Ontario (BAO).

As part of the Funeral, Burial and Cremation Services Act, 2002, the operator is required to hold a "Care and Maintenance Fund" with an independent trustee for the perpetual care of the niches and plaques. Silver Spire's trustee for this fund is Thorold Community Credit Union. From January 2022 the requirement is to hold an amount of \$165 or 15% of the sale price of the niche for each one sold. Our current liability is \$7,930. Account balance is \$10,480.86. See Note 6 for more detail.

Prior to 2019 the fee for the niche included the cost of the plaque, which is paid out of the fee at the time of service. Consequently, an amount has been set aside as a plaque reserve for the purchase of the future plaques. This amount is adjusted as needed for the changing cost of the plaques. From 2019 onwards the niche purchase fee does not include the cost of the plaque, which becomes the responsibility of the purchaser at the time of the service. See Note 6 for more detail.

### Plaque Reserve

These funds have been established to provide for the future cost of the plaques purchased before 2019 and the cost of plaque maintenance, and are adjusted from time-to-time to account for plaque cost increase. See Note 6 for more detail.

### 4. Falk Estate

In 1986 a bequest in the amount of \$50,000 was received from the Estate of the Late Elizabeth G. Falk. Pursuant to the terms of the will the principal is to be invested and the income derived from the investment paid annually to a beneficiary for his lifetime. Upon the death of the beneficiary the investment and interest shall be paid to the endowment fund of St. Paul Street United Church (now Silver Spire). The funds are held in a separate trust account and are not included in the financial investments of Silver Spire United Church.

The market value as at December 31, 2022 is \$410,087.65. Value at December 31, 2021 was \$453,254.71

# Silver Spire United Church Statement of Income and Expenses 2022 and Budget 2023 Notes to the Financial Report and Budget

### Summary

Total income for 2022 was less than expected, not including the final donations for the shower project. Expenses though were up, mainly due to increases in staff costs, insurance costs, technology costs, outreach expenses, natural gas and building repairs and maintenance. Due to this, an increase in transfer from the investments was required, with \$200,000 from the unrestricted funds compared to \$125,000 in 2021.

John Empringham and Lowell Scott continued with the duties of Co-Treasurers. During the year, KAS Business Services was hired to ensure a smooth transition of our accounting systems to one system and to allow for direct help with any problems. Thanks to Jim Graham for finding this bookkeeper and making the arrangements for this.

### Income

*Total Collections*: were down by \$3,279.61. The continued pandemic definitely affected our collections, but the hope is that 2023 will show a continuing return to church physically and also in financial support.

*Mission and Service Fund*: This is a pass-through account. All monies collected are forwarded to the United Church of Canada, Mission and Service.

*Invested Funds*: As stated above, we requested \$200,000 to be transferred from the unrestricted funds to the General Fund, due to increased expenditures.

**Rental Income**: \$72,513 in rental income was received in 2022, up from \$28,672.50 in 2021. Approximately \$20,000 of this was due in 2021 but not paid until 2022. A comprehensive Rentals Report has been received by Council and will be used in future planning.

### **Expenses**

Salaries, Contractors and Benefits: Salary costs were up \$30,977.08 over 2021. For 2023, a cost of living raise of 3.4%, as recommended by the United Church of Canada, automatically is given to the ministers. Raises were also approved for the office administrator, head caretaker, part-time cleaner, youth leader and shower attendant. Silver Spire is now able to make application to be recognized as a living wage employer. M&P recommended that Silver Spire move to operating on an egalitarian team ministry model where there is pay equity among team members. Both ministers will now be paid 14.8% over base for 2023. This is what Rev. Jane was receiving and increases Rev. Karen from 7% over base. Additionally, the United Church of Canada has changed the pay categories and both ministers will receive an increase in July. The amount will be an additional \$357.25 per month for each minister, effective July 1, 2023.

**Building**: There is a planned boiler replacement and HVAC upgrade project. Money will have to be raised for this.

**Assessment, Bank, Insurance**: The United Church Assessment has increased from \$14,815 to \$15,851 in 2023. Insurance costs have increased again this year, from \$24,684.48 to \$37,288.08 in 2023. In 2022, our GIC matured and the interest earned was paid into the General Fund. Consequently, our bank charges show as a negative number on the financial statement.

### Balance Sheet Dec. 31, 2022

At the time of printing the Annual Report the Balance Sheet was not ready. It will be distributed at the AGM on March 5, 2023.

Note 7 Special Project: Furnace Boiler Replacement and HVAC upgrades. Estimated cost \$250,000. This project will require searching for grants and fundraising. Any additional funds will come from the Silver Spire Investments.

Note 8 For 2022, Outreach Programs for OOTC, etc. have been shown separately from Schedule 3. For 2023, they are not separated.

Note 9 In 2022, this schedule included Special Projects.

Note 10 Interest and bank charges are a credit this year due to the interest earned on a GIC that matured.

Note 11 Insurance premiums have risen due to the global pandemic. Our broker looked for better rates but this is the best available. We continue to pay for claims made 2 and 3 years ago.

Note 12 Remainder of designated funds included in Outreach and Worship expenses on Schedule 3.

Chair, Ellen Gretsinger, read out the following on behalf of Dorothy Franklin and Shirley Scott: If you downloaded the first version of our 2021 Annual Report or picked up an earlier copy, you need to note that on the Personnel list on pg. 5, Rob Case, our shower attendant, Trinity Schwenker, A/V assistant and Joan Schwenker, volunteer were omitted in error and that Cheryl Deslaurier was listed in error.

Also, the financial statements for the church contained some errors and should be disregarded. We have the corrected financial statements available for you today.

We also deeply regret that Russ Plumley's name was omitted from the "In Memory" section in both emailed versions of the report and has now been included. Also corrected in 'In Memory", Jacqueline Birmingham's name was first listed with an incorrect last name.

Thank you to all who drew these errors and omissions to our attention so that we could correct them in compiling the record of Silver Spire for 2021. We sincerely apologize for any hurt these errors and omissions may have caused to individuals and families affected.

Joyce Little thanked David Hall on behalf of the Worship committee for leading the music ministry during 2021.

Shirley Scott spoke about the financial report from the trustees. In 2021, \$125,000 was transferred from investments to general fund, also \$12,893 from the designated bequests to the UCW, Outreach and Choir. 2021 was an exceptional year for our investments and we finished the year with a \$35,522 increase in our investment portfolio. This was due to strong markets and Council doing a good job of letting the Board of Trustees know what the projected needs for the year would be. She acknowledged Doug Hunt's contribution to the team — he is retiring.

John Empringham thanked Dorothy Franklin and Shirley Scott for their work on the preparation of the Annual Report. He also thanked David Reed, Eleanor Reed, Jim Graham and Lowell Scott for their treasury work in 2021.

John and Lowell will be recommending that Silver Spire hire a professional to do the work of the treasurer moving forward.

John directed our attention to the information contained in the notes. He also noted insurance costs went up substantially from 2021 – 2022. The church is entitled to claim GST/HST rebate which will be substantial due to the cost of the shower renovation and this claim will go in, over the next 6 months.

Question from Zoom: David Reed - Could someone from Outreach give us a run-down of what the \$49,700 budgeted for expenses would be used for. Kathy Reid from Outreach outlined that expenses go toward the operation of the shower program, running our Morning Prayer ministry and our Out of the Cold and Bear Clan programs. The hope is that much of those budgeted expenses will covered by grant money, some that is already in hand and some that will be applied for in the coming months. Rev. Karen added that the church has received a \$5000 grant towards operation of the showers. \$30,000 of a \$50,000 grant received in January will be used towards the operation of the shower program. A \$10,000 grant will fund the queer kids camp and a\$5000 grant will be used for community kitchen.

John noted that a transfer of investments of \$127,640.40 will be needed to balance the 2022 budget,

Celestin Nkulu asked why the budgeted amount for Office Administrator was less in 2022 than the 2021 budget amount. John answered that our previous office administrator had a number of years experience in the role and was earning a higher salary than our new office administrator who is just starting in the role.
